Landcare NSW is a grassroots movement acting to create a healthy habitat for nature and people to build sustainable communities. Our mission is to be a strong representative body working for a community Landcare movement that promotes and advocates for ecologically sustainable development in NSW.

We are looking to develop long-term relationships with individuals and organisations that share our ethos and commitment to the environment and have the ability to support us to continue our work. Your support would help Landcare NSW strengthen the infrastructure that supports the local operations of Landcare groups. **We would be pleased to work with you to ensure your funding is directed in ways that are important to you.** Examples include:

- **Funding a local Coordinator** – \$75,000 provides a community with their Coordinator and an implementation budget to build local leadership. Coordinators undertake environmental education initiatives for school children, restoring habitats and biodiversity, or facilitating the adoption of sustainable agricultural practices. We currently have 66 part-time Local Landcare Coordinators – who are part of the fabric of their local communities vital to unlocking the local investment and building partnerships that achieve the environmental change their community identifies, in a way that builds their resilience.
- **Leadership and training** for Coordinators and Committee Members – up to \$10,000 per activity. More than 80% of our coordinators are women, located in regional and remote communities.
- **Improved technology and communication** support across the network – sharing learnings in regional and remote areas.
- **Environmental policy design and program delivery** - providing a pathway for community voices to be heard.
